2. Purposes of processing personal data

Personal data (usually referred to just as "data" below) such as name, address, telephone number, email address, bank account and so on, will only be processed by us to the extent necessary and for the purpose of providing a functional membership administration and to offer the society's services (e.g. invitation to the AGM, direct debit of membership fees, membership list, organisation of annual conventions). Beyond this personal data may be published in conjunction with coverage of regional or national conventions on the society's website, magazine or social media publications.

3. Legal basis for the processing of data

The processing of personal data is usually based on the need to fulfill a contract in accordance with Art. 6 Para. 1 lit. b) GDPR. The contractual relationship is primarily the society membership.

4. Recipients of personal data

Members' bank account details will be disclosed to our bank institute for the purpose of direct debit of membership fees.

Beyond this personal data will be disclosed to our printing company for the purpose of printing and mailing of our magazine, invitations, general announcements and other printed matter as well as the membership list (only with member's consent). In any other case data will be disclosed to third parties with member's consent only.

We will not disclose data for advertising purposes

5. Duration of data storage

Personal data will be stored for the duration of the membership. They will be deleted upon a member's leave, exclusion or death as long as the deletion is not a breach of statutory storage obligations.

6. Rights of members and data subjects

All members have the right to information about the data being processed, to correct or complete incorrect or incomplete data, object to future processing of their data pursuant to Art. 7, Para. 3 GDPR or to file complaints with the supervisory authority.
